Zone 1: Major Quiler at (404) 799-2488 reported that there is concern that AUC students are going into neighborhoods where they do not belong; they are putting themselves in harm's way and he urged everyone to stay close to campus, especially late at night. In the AUC area, prostitution is down.

Zone 4: Sgt. Oliver reported on panhandling; One recurring offender was sentenced to 90 days, the longest sentence seen for panhandling; Due to the JAG Grant, the number of policemen has been increased for the short term of 60 days only.
