Either way, I thoroughly enjoy the strategic process that is at the core of chess. There is always a lesson in the game.

One of the things I have learned with chess and the game of life is how important it is to have goals. Jim Cathcart, a noted professional speaker, once said, "Most people aim at nothing in life and hit it with amazing accuracy." If we don't specify exactly what we want, we have no reason to complain about what we get or where we find ourselves.

This maxim is as true for a communal enterprise like Neighborhood Planning Unit T as it is for individuals. In order for NPU-T to thrive beyond the mundane tasks of processing applications for city licenses and permits, we must be willing to challenge ourselves to achieve community building objectives. These goals must be conceivable, believable, achievable, measurable, controllable, and with purpose.

As you have seen, your neighbors have stepped up in good number to take on this challenge by chairing and serving on the various committees of NPU-T. Of course, we are always grateful for the service and leadership of our neighborhood association presidents. It is important to remember that unlike elected officials at a higher level, none of us are paid or receive any compensation beyond the satisfaction of serving our neighbors and building a better community for our families.  - Mortgage Fraud (with an eye towards a Community land Trust as a solution)
 - Comprehensive Economic Development Strategy (in partnership with the Atlanta University Corridor Vision Team)
 - The Beltline Project
